**Q3** (excluding neutrals). Has any of this caused you to change your strategic plan or ongoing funding priorities? [If necessary, prompt to see if foundation is doubling down on existing programs, or adding new ones, or both.]

**Q4.** Have you or other leaders at your foundation taken any actions, *beyond funding*, in response to the election? For example, speaking out through the media, signing a petition, joining or withdrawing from a government commission, etc.

**Q5.** A final question and then I'll let you get back to your day job. Some foundations have pledged money to advocacy efforts to stop Trump. Others have been noticeably silent even though many of their programs are being harmed by Trump. Is it the role of foundations to engage in advocacy to fight for or against a president? Or in general terms should foundations stay away from advocacy before government?
